PROVISION OF DESIGN AND CONSTRUCTION OF PURELY ANAEROBIC WASTE WATER TREATMENT PLANT (DIGESTERS) AFFORDABLE HOUSING SCHEME PHASE III

1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in **Tanzania Procurement Journal (TPJ)** dated **Tuesday, 23rd June 2015**.
2. The Board of Trustees of National Social Security Fund has set aside funds for its operations during the financial year 2015/2016. It is intended that part of the proceeds of the funds will be used to cover eligible payments under the contract for **Provision of Design and Construction of Purely Anaerobic Waste Water Treatment Plant (Digesters) for Affordable Housing Scheme Phase III**.
3. The National Social Security Fund now invites sealed bids from eligible contractors registered in **Waste Water Management or Biogas Contractor Class One** for proposed Design and Build of Waste Water Treatment (purely Anaerobic System) Affordable Housing Scheme Phase III.
4. Bidding will be conducted through the **National Competitive Tendering** a procedure specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 and is open to all Tenderers as defined in the Regulations.

Interested eligible Tenders may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board, 7th Floor, NSSF Head Office, Benjamin William Mkapa Pension Towers (Tower B) Azikiwe Street, P. O. Box 1322, Dar es Salaam, from 8.00am to 5.00pm on Mondays to Fridays inclusive except on public holidays.

A complete set of Bidding Document(s) in English Language and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **TZS. 200,000/= (Tanzanian Shillings Two Hundred Thousand Only)**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to National Social Security Fund, Benjamin William Mkapa Pension Towers P.O. Box 1322, Dar Es Salaam.
7. **All Tenders must be accompanied by a Tender Securing Declaration in format provider in Tender Document Section X.**

All tenders in one original plus two copies, properly filled in, and enclosed in plain envelopes must be delivered **at the NSSF Conference Room, 16th Floor of Benjamin William Mkapa Pensions Tower (Tower B) Azikiwe Street, Dar es Salaam at or before 3.00 pm on Tuesday, 20th October, 2015**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **NSSF Conference Room, 16th Floor of Benjamin William Mkapa Pensions Tower (Tower B) Azikiwe Street, Dar es Salaam**.
9. Late bids, portion of bids, electronic bids, and bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstance.
