It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for supply and installation of Furniture, Carpet walls and Public Address System to Conference Hall for The Proposed Kilimanjaro Commercial Complex.
2. The National Social Security Fund now invites sealed bids from eligible Suppliers of **Furniture, Carpet Walls and Public Address System to Conference Hall for The Kilimanjaro Commercial Complex on Plots No. 7, 8 and 9 Block "C" – Agakhan Road in Moshi Municipality**
3. Tendering will be conducted through the International Competitive Bidding procedure as specified in the Public Procurement Regulations, 2013– Government Notice No. 446 and open to all Tenderers.
