1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in DailyNews dated 27th July 2016.
2. The National Social Security Fund has set aside funds for its operations during the financial year **2016/2017**. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for Renovation of NSSF Mwanza Commercial Complex.
3. The National Social Security Fund now invites sealed tenders from eligible contractors registered in *Class Five and Class Four as Building Contractor* for Renovation of NSSF Mwanza Commercial Complex.
4. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 and is open to National Tenderers only as defined in the Regulations unless otherwise stated in the **Tender Data Sheet**.

Payment should be by Cash payable to Director General, National Social Security Fund, Benjamin William Mkapa Pension Towers (Tower B) P.O. Box 1322, Dar es Salaam.
7. All Tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.
