2. The National Social Security Fund has set aside funds for its operations during the financial year 2016/2017. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contract for Renovation of Mikocheni Executive Apartments.
3. The National Social Security Fund now invites sealed tenders from eligible building contractors registered with Contractors Registration Board (CRB) for Class Five and above.
4. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 and is open to national Tenderers only as defined in the Regulations unless otherwise stated in the **Tender Data Sheet**.
